

# MICROSOFT CODE HUNT INTERN EMPLOYEE CONTEST

## OFFICIAL RULES

### CONTEST DESCRIPTION:

This is a skill-based Contest. The object of this Contest is to write code in a skill based game consisting of a number of sectors and levels. For purposes of this Contest, each set of levels entered on the [www.codehunt.com](http://www.codehunt.com) website you create and submit in the Contest will be called an "entry." All eligible entries received will be judged using the criteria described below to determine the winners of the prizes described below.

### WHAT ARE THE START AND END DATES?

This Contest starts at 19:30 Beijing time on August 13, 2015, and ends at 20:30 Beijing Time on August 13, 2015 ("Entry Period").

### CAN I ENTER?

This Contest is open to any Microsoft intern based in the Beijing, Shanghai and Suzhou Labs; however, any person directly involved in the development or execution of this Contest is ineligible to enter. If you are a person with a disability and would like to request an accommodation, please contact [codehunteam@microsoft.com](mailto:codehunteam@microsoft.com) and request assistance in entering this contest.

### WHAT CONSTITUTES AN ELIGIBLE ENTRY?

To be eligible for judging an entry must meet the following content / technical requirements:

- Get as far as you can playing the Code Hunt game in the Code Hunt China zone.

All entries submitted must be original work developed while an employee of Microsoft, and all entries will become the sole intellectual property of Microsoft. By accepting a prize you agree to sign any necessary documentation required for us and our designees to make use of your entry.

### HOW DO I ENTER?

In order to participate in this Contest, you must go to the Contest web site at [aka.ms/codehuntinterns](http://aka.ms/codehuntinterns) and complete and submit the online entry form, including submission of your entry, as instructed. You will then be directed to the Intern zone in the Code Hunt game, which will be open during the entry period.

We will only accept one (1) entry(ies) per person.

### WINNER SELECTION AND PRIZES

On or around the close of the Entry Period, a panel of judges will review all eligible entries received and select winners of the Contest Prizes described below based upon judging criteria described below.

#### Judging Criteria

- 100.00% - Highest score achieved

The decisions of the judges are final and binding. If we do not receive a sufficient number of entries meeting the entry requirements, we may, at our discretion, select fewer winners than described above.

In the event of a tie between any eligible entries, the winner will be determined as follows:

1. Highest sector scored (higher is better)
2. Highest level in sector scored (higher is better)
3. Last scoring time (earlier is better)
